Looking for a quick and easy homemade gift for your friends and neighbors? Here is a recipe for quick fudge.


You will need;

Coyotes

You may have noticed we have some wild neighbors roaming through our wetlands lately. Every few years the coyote's come back into our area. We must remember that this area once belonged to them and we must learn to live responsibly with our wild friends. They will tend to keep to themselves and leave us alone. There are certain precautions you should take to help protect your family, pets and property.

- 1. Do not feed wild mammals!
- 2. Feed your pets in the house.
- 3. Always keep your garage doors closed.
- 4. Equip all of your windows with properly
- maintained screens. 5. Keep pet doors locked at night and when not in

use during the day. 6. Cover your children's sandbox when not in use to prevent it from being used as a litter box by wild mammals.

7.Enclose compost bins, and lock or securely tighten trash can lids to eliminate food sources for wildlife. 8.You can prevent wild animals from selecting your home as their habitat by increasing the amount of human activity that takes place in your yard. Spending time in your yard each day is one of the most effective ways of keeping wild animals away.

SMOKE/FIRE ALARM ALERT

With the winter heating season approaching, it is time to check on the combination smoke/fire alarm furnished with most of our homes. Most homes received *FireX* Model ADC Item 4518 units. To keep your families and your homes safe, you need to be familiar with the unusual characteristics of these units and perform periodic maintenance to assure they are still working properly.

The units are extremely sensitive to dust. Even minor specks of dust can cause the units to malfunction sometimes causing them to emit a warning sound and sometimes they fail without any warning at all. The manufacturer recommends that the units be opened and "blown out" with canned compressed air at least once each year. I can tell you that even "clean" units will have a surprising amount of dust accumulation!

The units are "hard wired" to your electrical service in your house. They are also equipped with standard (short life) 9 volt batteries for back up protection if your electrical power is interrupted. The units are connected in parallel, so if one alarm is out of service (unplugged), the rest of the units should still operate. Also, if one unit detects smoke then all units are supposed to sound an alarm. The alarm for any one unit is quite loud, so be prepared to be instantly alert if your alarms begin to sound!

The Tualatin Valley Fire and Rescue Service told me these units are supposed to be equipped with long life 9 volt batteries that have an expected life of 8 years. A neighbor who sold his house in Arbor Ridge was forced to install long life batteries in each of his alarms before the sale of his house could be completed. Long life 9 volt batteries are hard to find and they are about \$8.00 each. The only place I have found that carries long life 9 volt batteries is Fred Meyer. When you install a new battery you must completely discharge the power in the alarm. To do this you need to open (twist) the alarm away from its mounting base and unplug it. Next remove the old battery and press the test button until the alarm stops sounding. Install the new battery, reconnect the plug, and close the alarm.

When a 9 volt battery grows weak the alarm unit will begin to emit a "chirping" sound. It may be a bit difficult to locate which unit is chirping due to the way sound travels. I sat on a chair under the suspect alarm and read a book until it chirped again.

Each unit has two LED's (light emitting diode). One light is green and should be lit at all times. That light indicates the house current is turned on and flowing through the alarm. The second LED is red and indicates whether it is in normal operation (a one second blink every minute) or if it senses smoke (blinks once per second and the alarm sounds). There is a test point on the face of each *FireX* unit that you can press. If you press this point (it is actually the red LED), the alarm will sound until you release the test button. A number of web sites have comments from *FireX* users. Most of those who wrote in were dissatisfied with the *FireX* units and had elected to replace them.
